The amount due is the 1st month's tuition (or session fee) plus an applicable registration fee for registrations received after August 15th. The registration fee is \$10 for a single student or \$15 for a family. An annual reg. fee does also apply to session clients. After the first month's tuition is paid; all future payments are drafted for your convenience out of the CREDIT OR BANK CARD account (including debit cards) of your choice. You may choose a draft date of the 1st of the month to receive the discount rate, or you may choose the 15th of the month for the regular rate. Please factor that the draft process in done on the 1st (for discount rate) or 15th (for regular rate) but could also post within the week timeframe listed: 1st-7th or 15th-22nd. You may also pay for costume deposits, and other fees with a credit or bank card if you choose (for East Dance Studios/JEDEC only, not applicable for any Dance Co. matters). *Please note; the discount or regular rate applies for your next month's tuition, and is due monthly through the recital. This is applicable for the core dance program (not sessions). The recital is traditionally in May (please be advised that East Dance Studios/ JEDEC has had to go into June before to accommodate recital auditorium rental issues—so though ending in May is traditional—June is also a possibility). To stop your responsibility to pay, you must send a certified letter to: East Dance Studios/JEDEC Central Business Office, 286 Central Street, Winchendon, MA 01475 stating your 30 day notice to withdraw. At which time, you are charged your last month's tuition, finish out the 30 days, and are then withdrawn from this season. Reminder: The 30 day withdrawal notice does not apply to sessions as they are individual programs. To guarantee placement in class, tuition and registration fee (if applicable after Aug. 15th) must accompany this signed registration form/contract. Please return this form/contract as soon as possible as classes have occupancy limits, which vary per age & dance form. Students are registered on first received first served basis.

We ask that our valued customers review the preceding and read the following prior to providing their signature for this contract. Thank You.

Upon the signature of this registration form/contract, accompanied by the 1st month's tuition, and any applicable registration fee, I understand the student listed is registered for the duration of the month I am enrolling for until the end of the 2011/12 dance season (ending at May's recital—June could be a possibility if our recital date of 5.19.12 was to be changed). As the responsible adult, I agree to pay all applicable tuition and related fees. I also understand that to cease my responsibility to pay tuition for the remainder of the dance season, in the event that the student wishes to drop out of dance class, I may do so by providing a 30 day advance written notice BY CERTIFIED MAIL, accompanied by the last payment/draft. The last payment due is the amount of my monthly tuition. At the end of the 30 days, the student will no longer be enrolled, thus I will incur no additional fees. **Note: Session clients void the 30 day advance withdrawal notice; sessions are separate programs that do not participate in the recital.** I understand and agree to be responsible for all payments, which are nontransferable and nonrefundable, unless the class I'm presently requesting is closed due to enrollment limits, in which case I'll be refunded for the payment enclosed. As performances are part of this program, I am aware that additional fees for (date sensitive ordering of) the recital's costumes and recital tickets will apply. I realize I can opt not to participate in the May recital by stating such in writing and mailing it to the CBO/Central Business Office before the Oct. costume deposits are due. I understand that in years a winter/Dec. performance is held that the entire student body is casted and participates in the frugal community show in addition to the May recital. I agree to read and be responsible for the information in the East Dance Studios/JEDEC Student/Parent Policy Handbook that is provided to all customers upon registration and/or upon request. I also realize any monies received after an account becomes delinquent will be first applied to the delinquent status. East Dance Studios/JEDEC advises that students receive their doctor's approval (after a complete physical) prior to attending dance or acro class. I understand East Dance Studios/JEDEC is not responsible for my child's medication, allergies, et cetera and agree to stay with my child and make advance arrangements to chaperone events if a medical issue exists. I understand that if injury or sickness was to occur, 911 may be called and I or my insurance is responsible for related costs. I understand that with dance or acro instruction/performance, as with any physical activity or contact training; there is a related risk of injury and agree not to hold East Dance Studios/JEDEC, its faculty, facilities, or proprietors liable in the event of an injury. I also recognize I am responsible for my child (attendance, waiting room, entering and leaving the building etc.) when he/she is at East Dance Studios/JEDEC. I understand pictures or videos may be taken and published throughout the dance season for use to celebrate and promote student accomplishments and East Dance Studios/JEDEC.
